

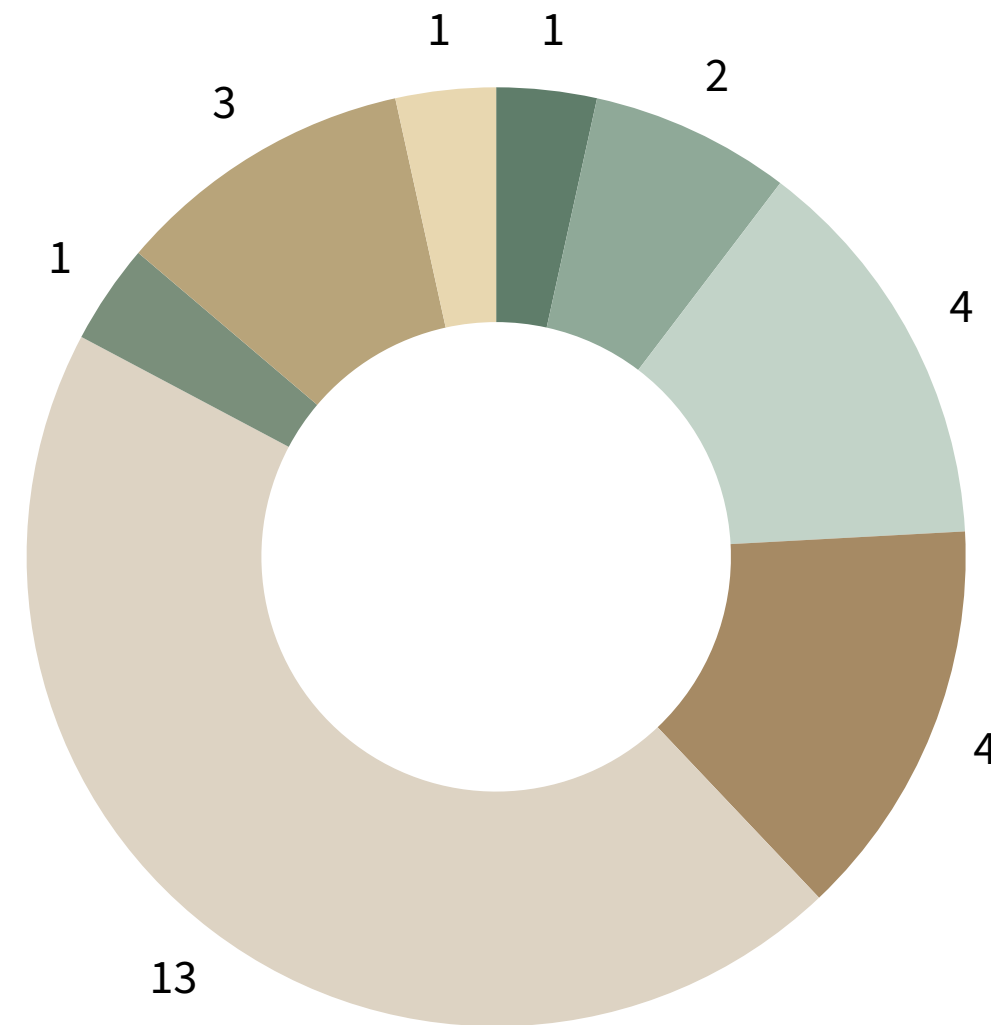

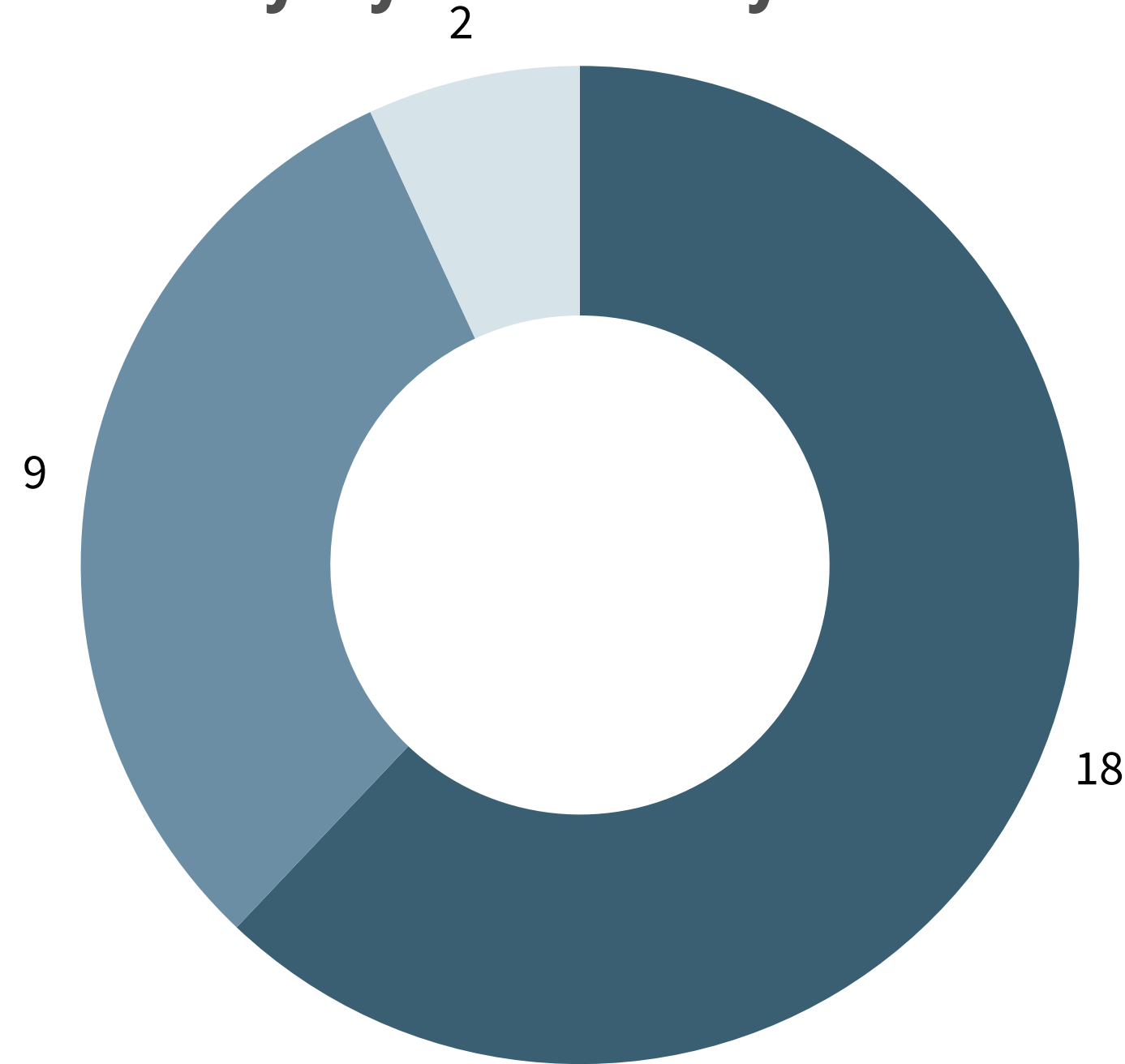

Did either of your parents attend university by the time you were 18?

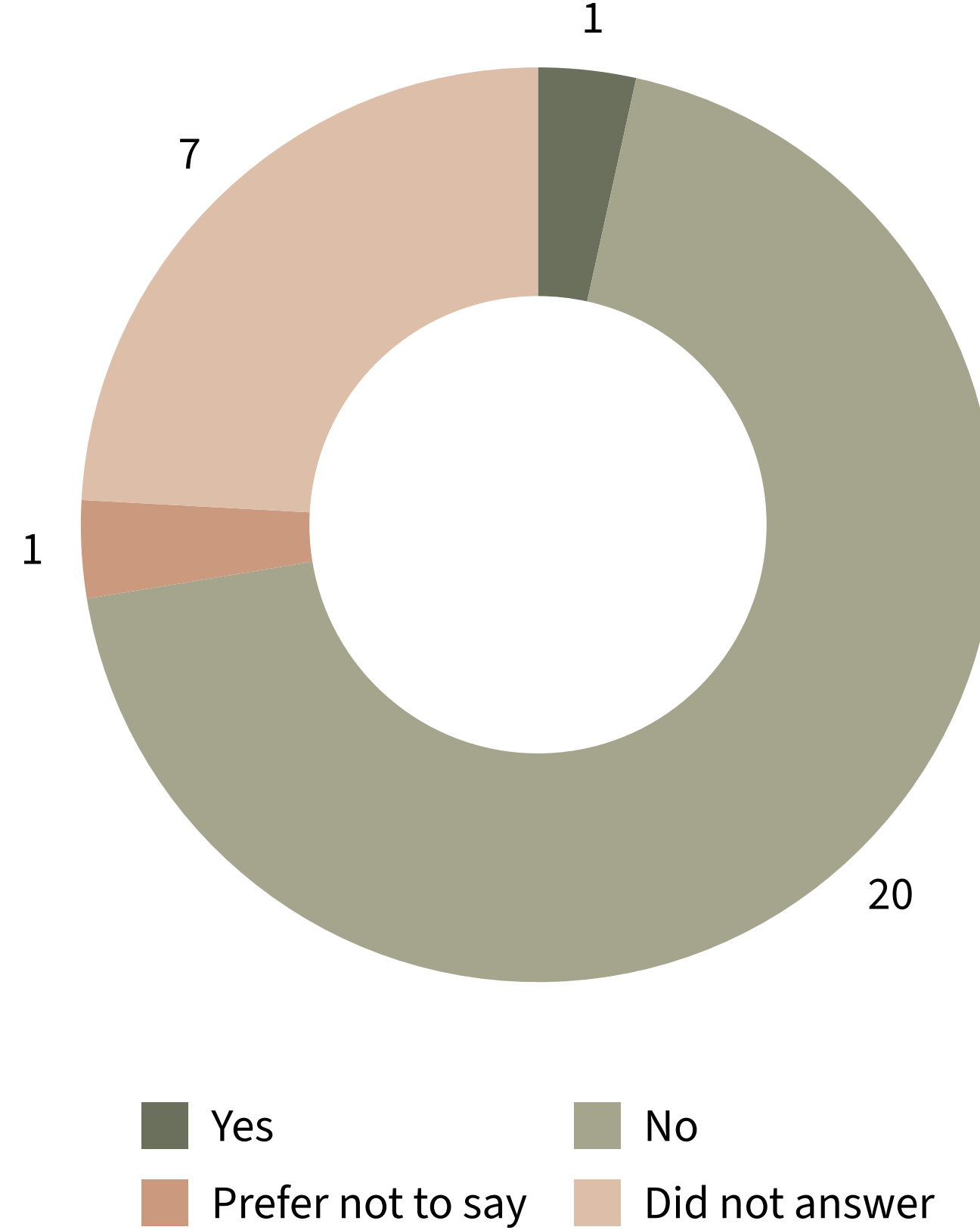

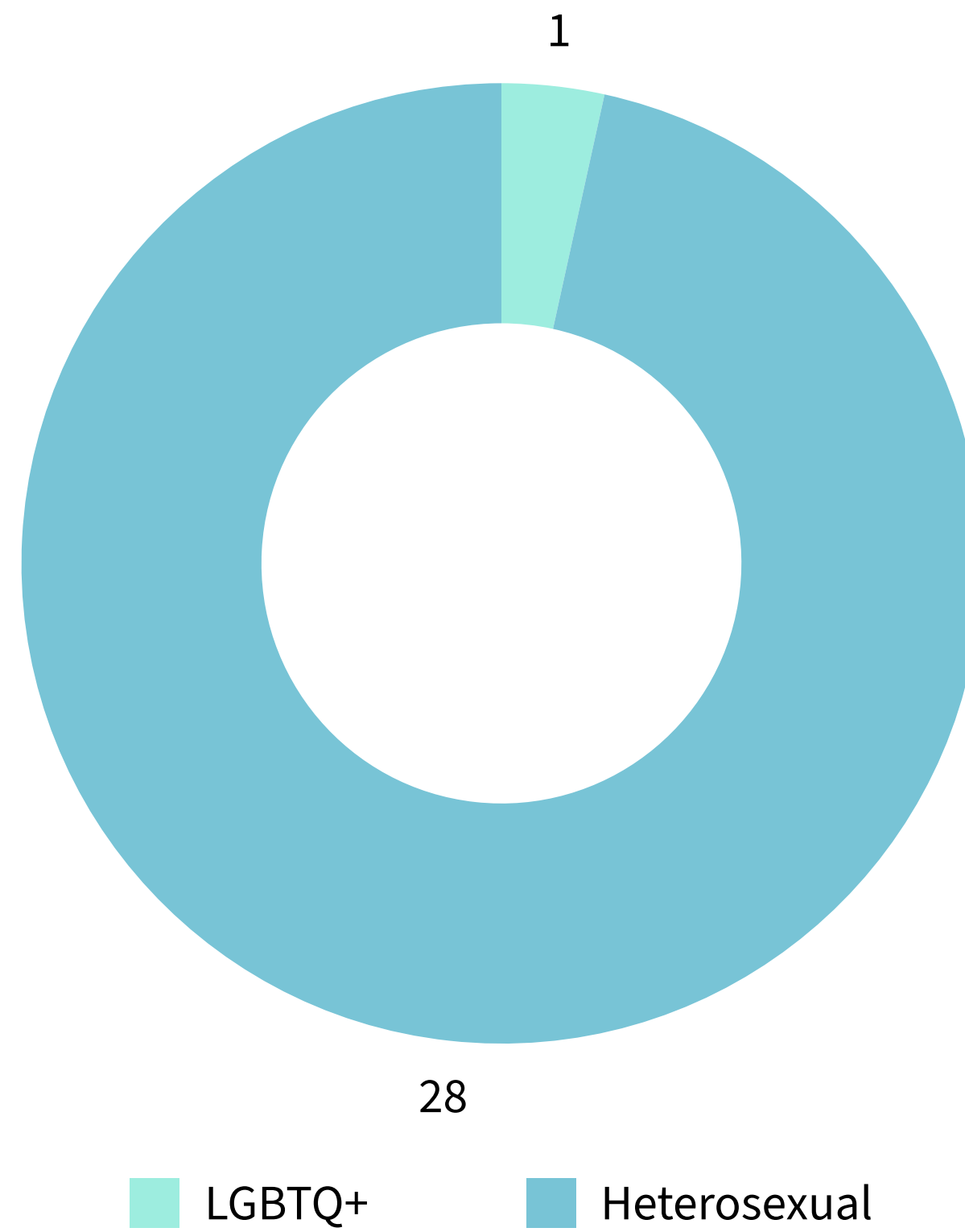

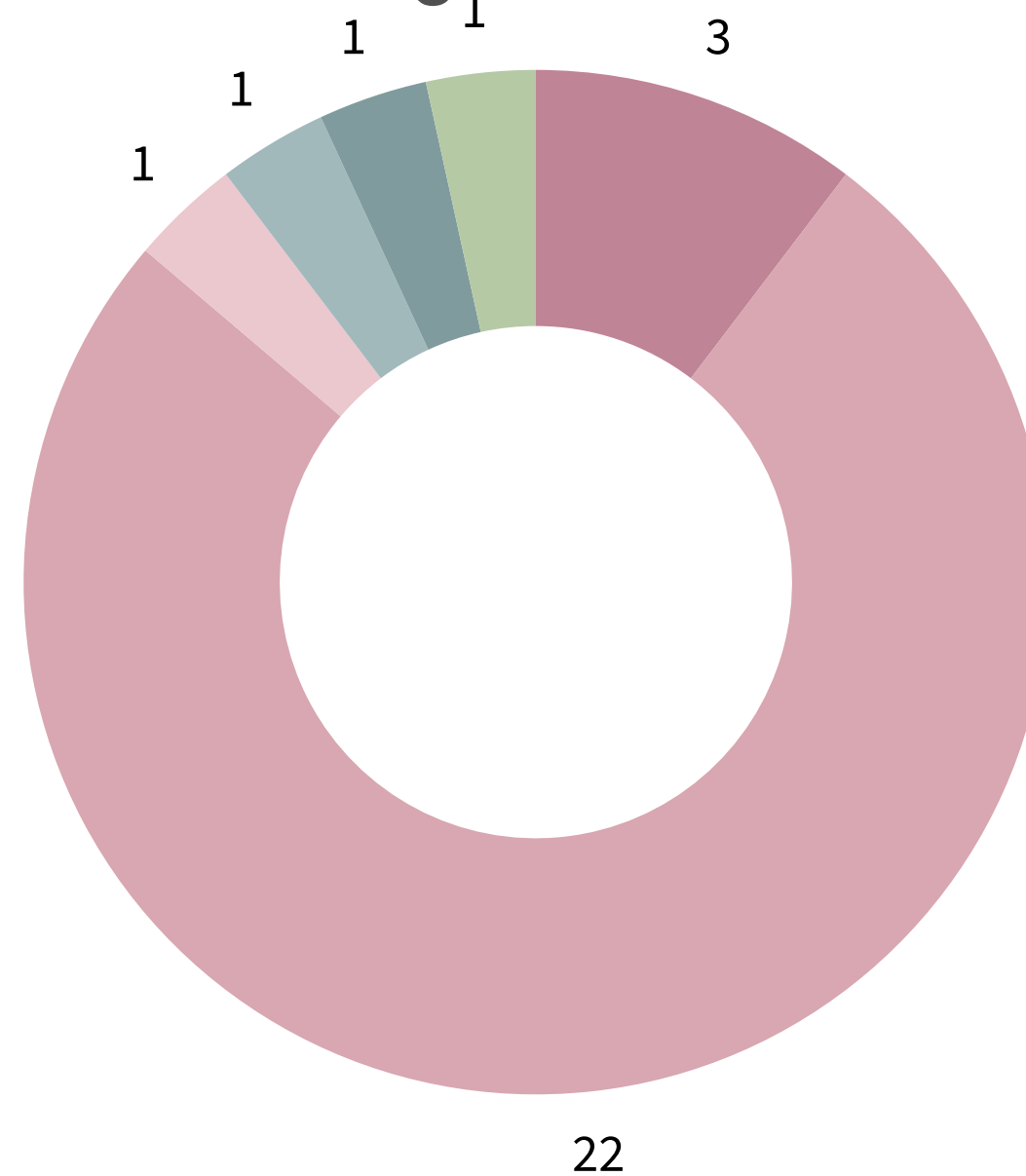

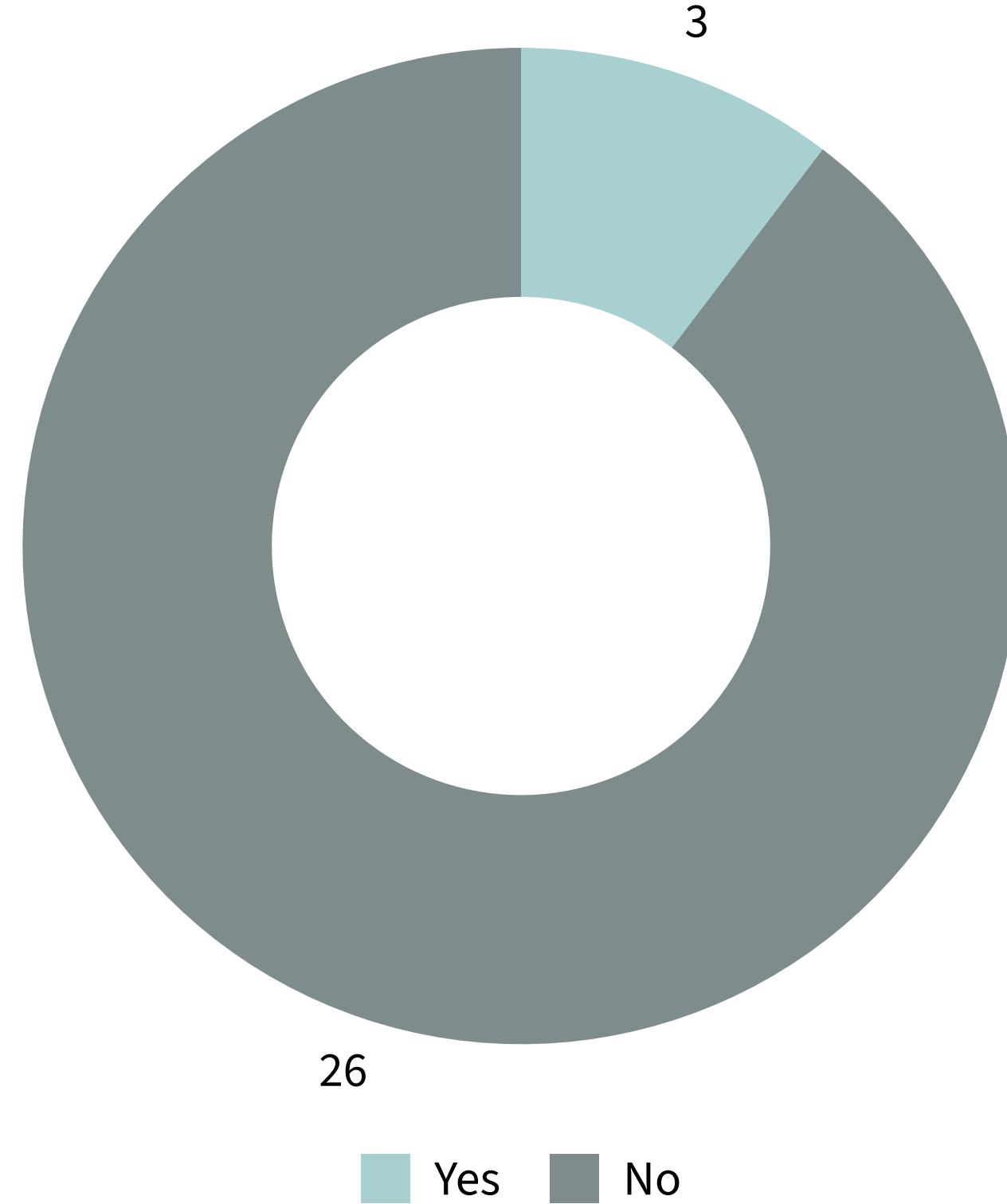

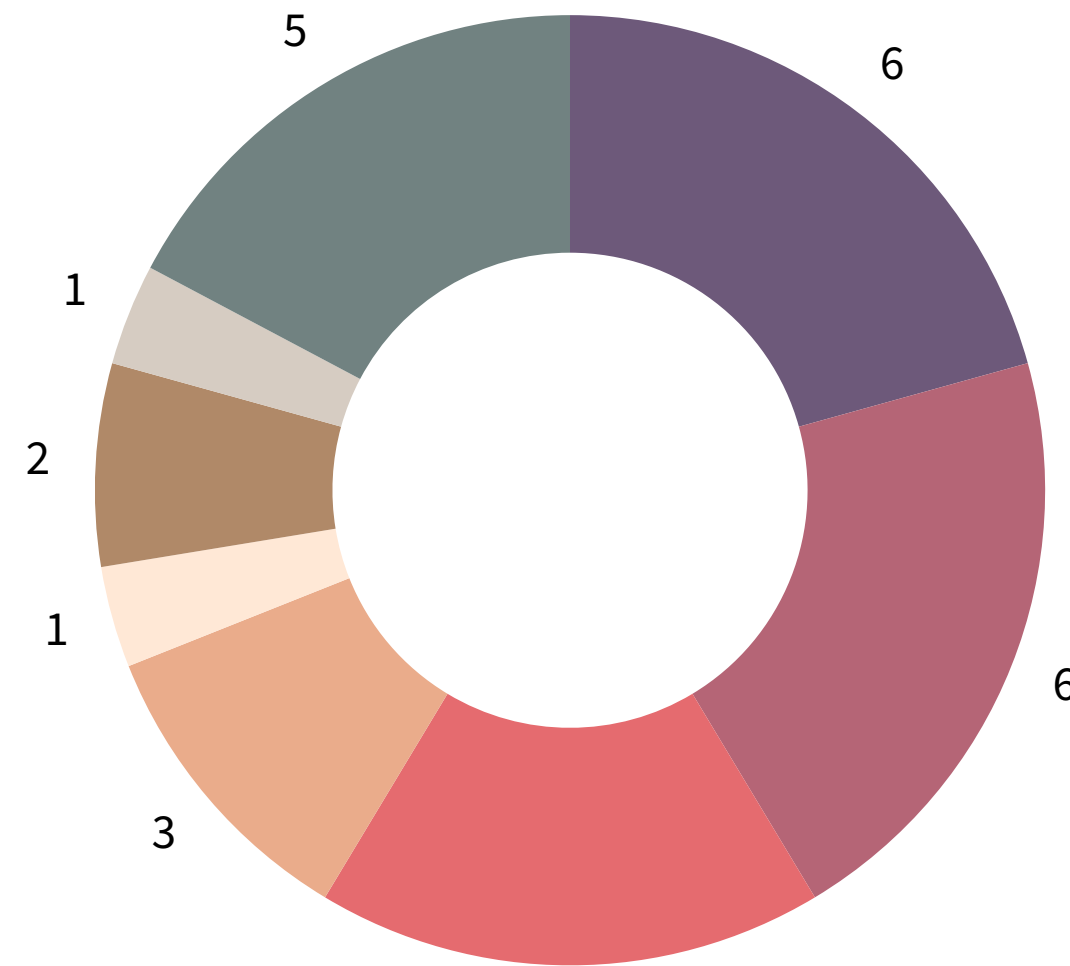
Do you consider yourself to have a disability as defined in the Equality Act 2010?

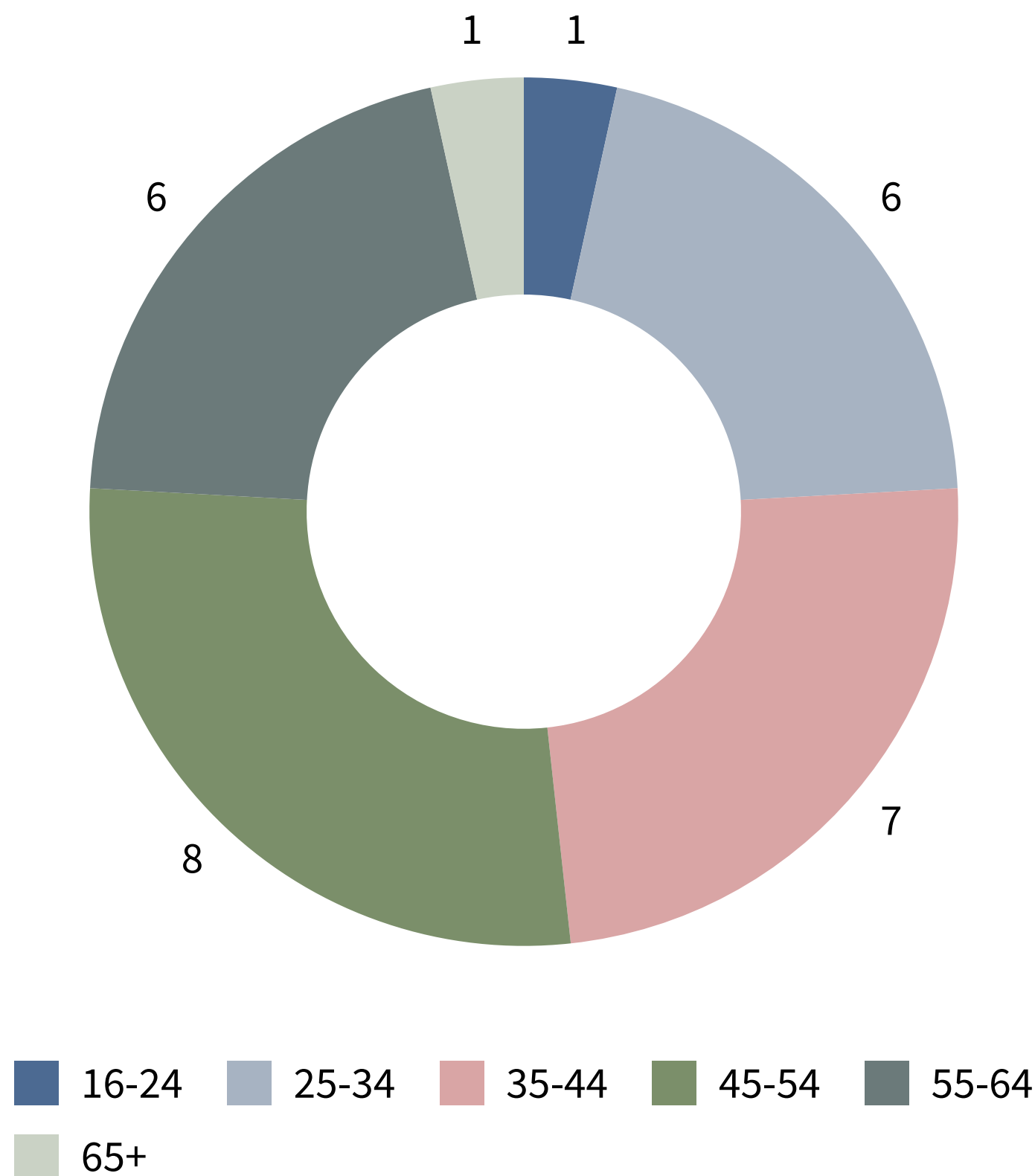

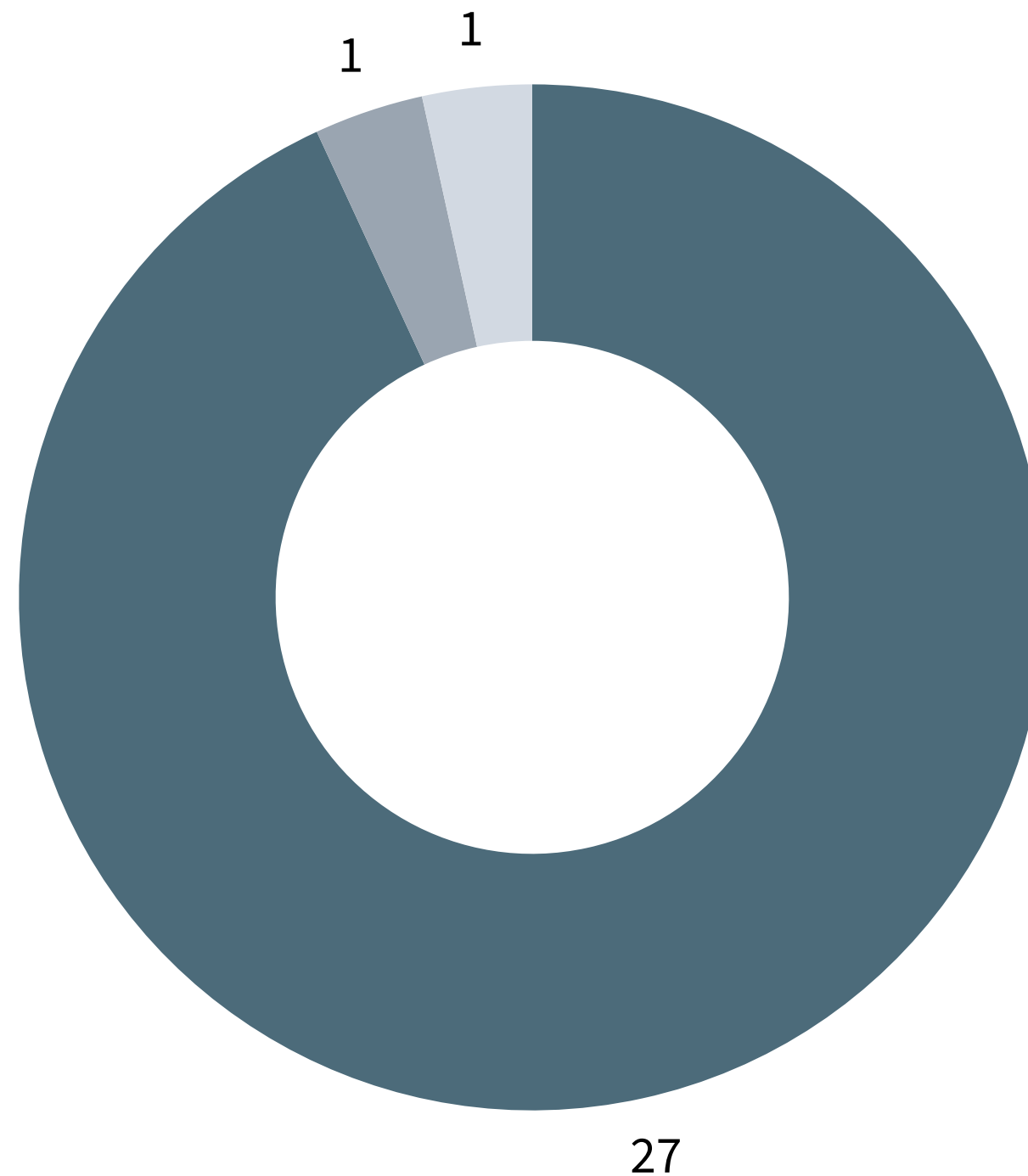

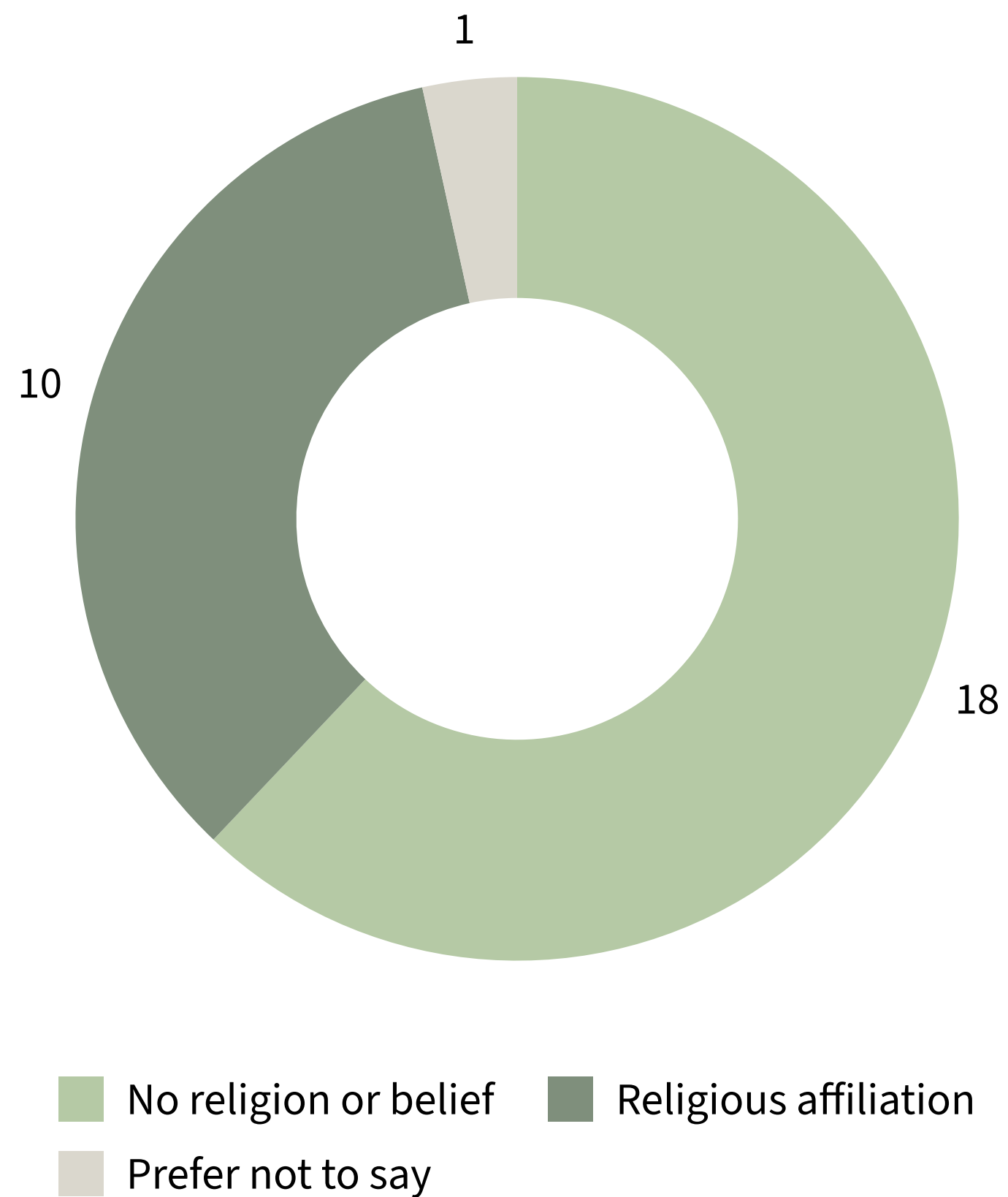

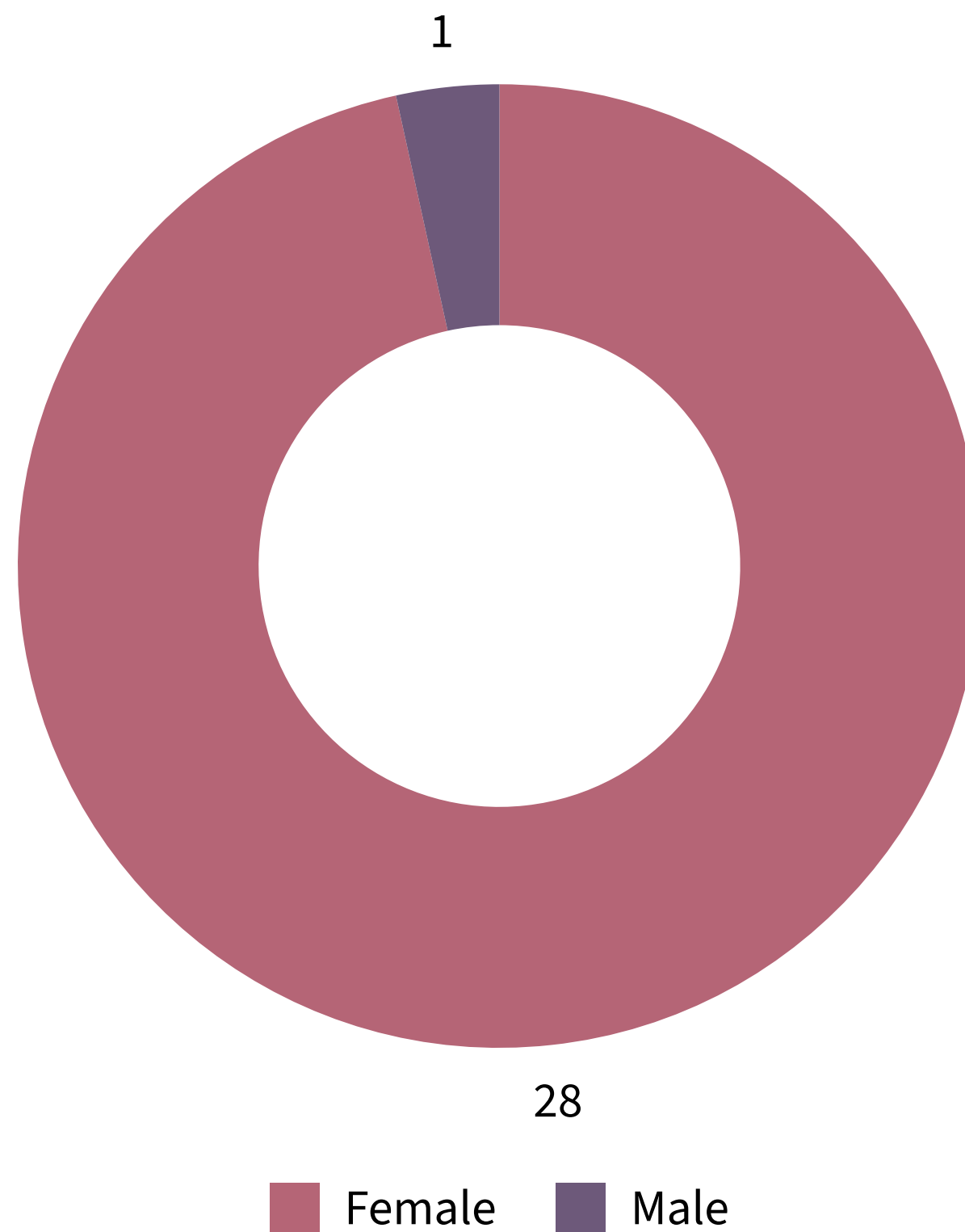

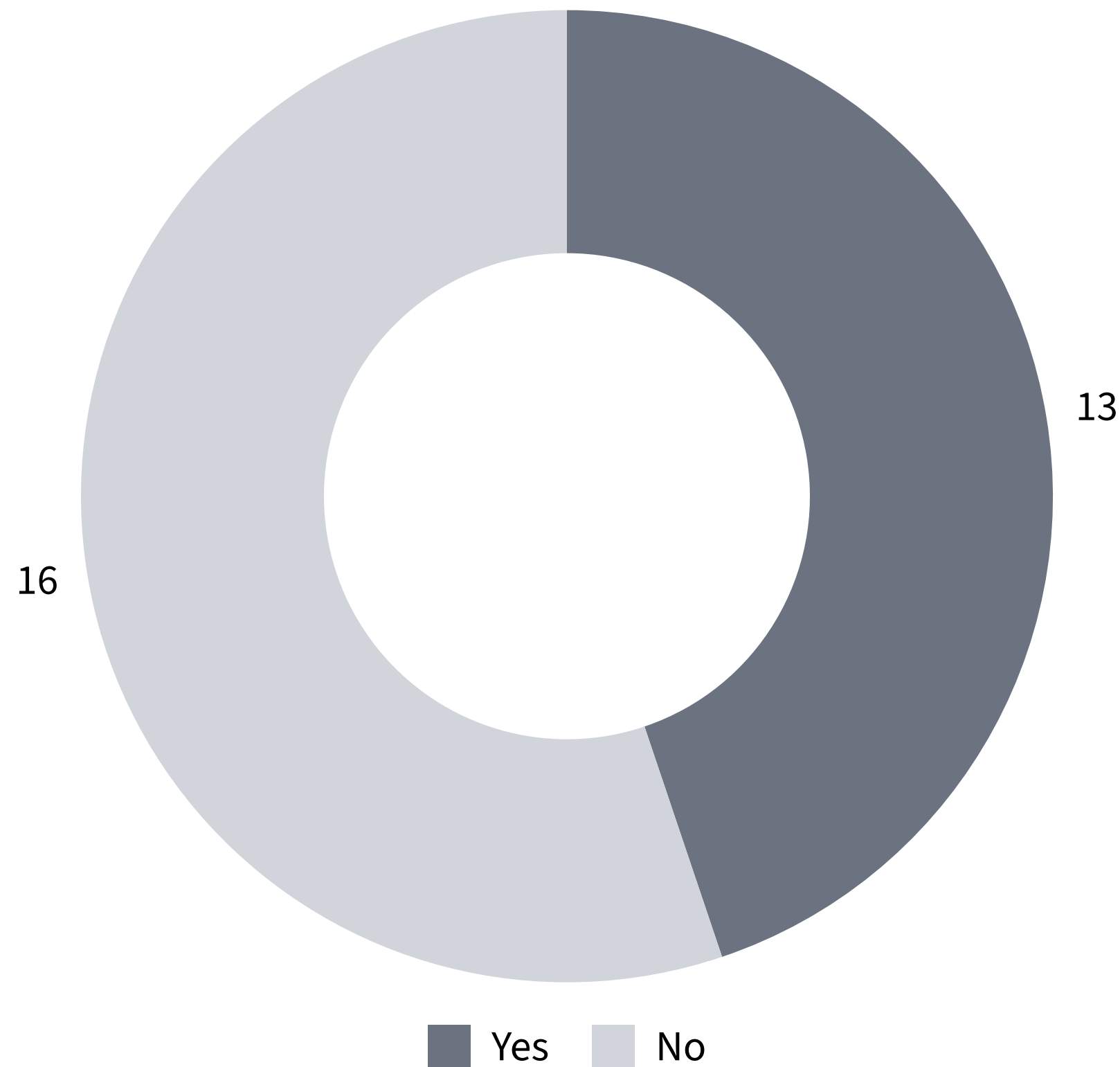

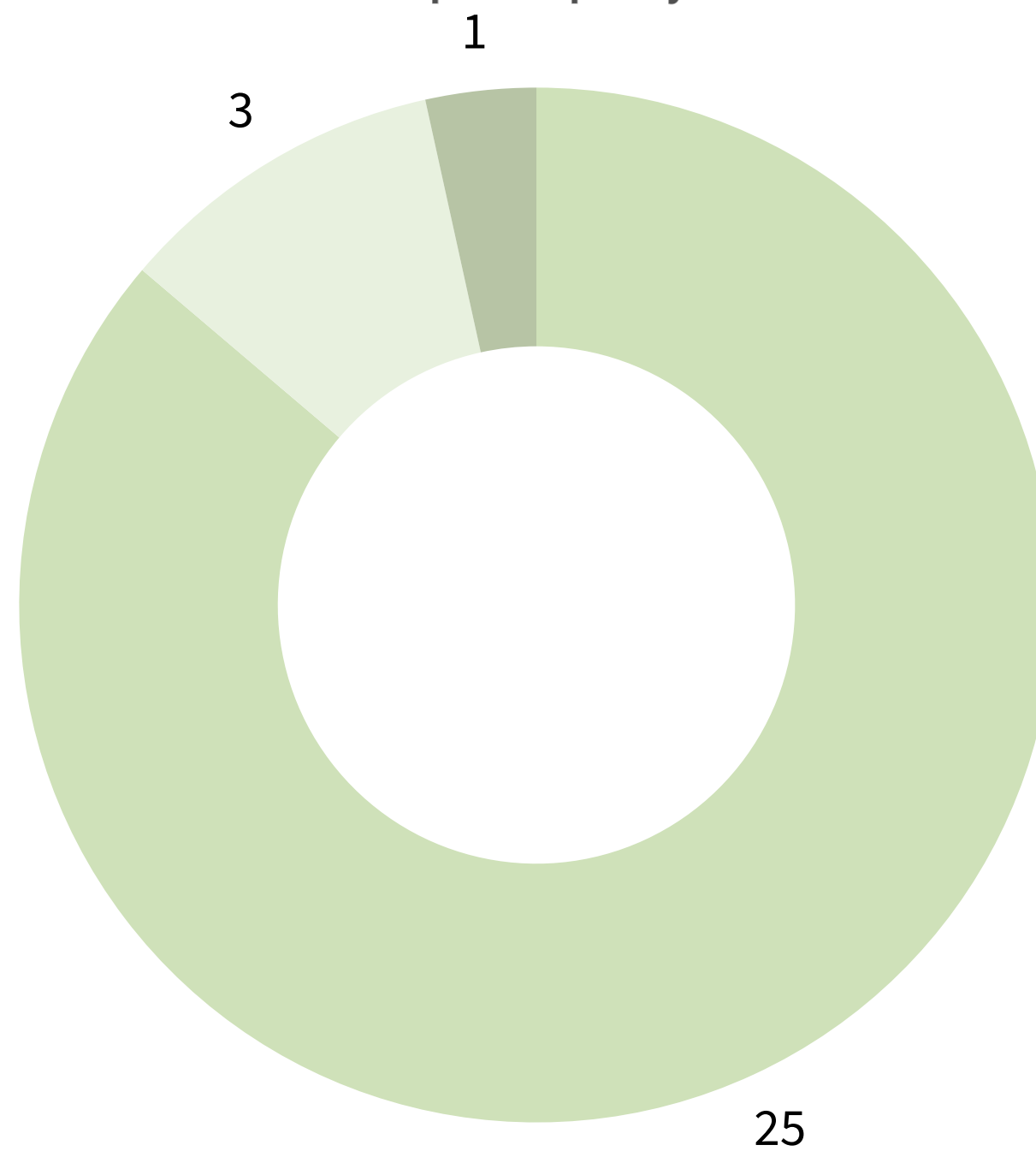
